The Chelmer Blackwater Reserve Community Interest Company (CIC) was formed by a group of residents concerned as to future plans for the land adjacent to the Tesco Supermarket in Maldon. In Feb 2022, the CIC signed a long-term lease with Tesco Stores Ltd to take control of the land and to develop it as a community nature reserve. All members of the CIC are un-paid volunteers and work is funded by a combination of grants and donations. Members of the public are actively encouraged to become shareholders and to participate in activities to support the management of the reserve.

CHELMER BLACKWATER RESERVE CIC WINS CONSERVATION AWARD

On 7th November we were very honoured to be declared winners in the Nature Conservation category of the Maldon District Conservation & Design Awards. This was the fortieth year of the awards, which aim to applaud and promote good quality development throughout Maldon District. The judges agreed our project "was an outstanding example of a grass-roots initiative to establish a nature reserve." They said they were "full of admiration for the mobilisation and enthusiasm of so many volunteers."

MAIN PATHS NOW ALL COMPLETED!

Work has now been completed to provide a more durable surface to the remaining section of path from the viewing platform to the public footpath along the western edge of the reserve. Many thanks to Wayne and his team from WLG Maintenance for carrying out the work ahead of time and within budget and to our supporters for providing the funds to support it all.

The next planned actions are to finalise and instal the information boards and to provide some protective edgings to some sections of the new paths that are at risk of breaking up.

If time permits, we would also like to attempt to clear a route to where we believe a pond is located to 'see what we can see' and there will of course be litter-picking to do as well.

Please bring along gloves, pruners/loppers and shovels and spades, if you have them. We can provide a few pairs of croppers as well. Please also wear sturdy boots.
